i) <u>Crisis Response</u> – Lori Hassall, Director of Crisis & Short-Term Intervention Services, CMHA Middlesex

# 7. Business Arising from April 4, 2016 minutes

#### 7.1 Mayor's Advisory Panel on Poverty – Abe Oudshoorn

The Mayor's Advisory Panel on Poverty final report, "London for All: a Roadmap to End Poverty" identifies 112 recommendations that are grounded in the best available research, the Social Determinants of Health and work already happening in London and across the country, and are the result of extensive public consultations. The goal of these recommendations is for London to reach its full potential by ending poverty in one generation.

Abe provided a brief update on ideas and initiatives that are currently underway for each of the recommendations put forth for Homeless Prevention and Housing. The membership was asked to consider the recommendations to determine which ones the London Homeless Coalition can best take the lead in, or contribute to.

- iii) Michelle Lynne Goodfellow will circulate the MAPOP recommendations under Homeless Prevention and Housing to the membership. Individuals are asked to provide an update on any current or upcoming initiatives related to the recommendations.

# 7.3 Local Poverty Reduction Fund – Call for Proposals – Deadline to submit a proposal - June 29, 2016 at 5:00 pm

The Province of Ontario, Local Poverty Reduction Fund has released its' proposal call. The Government of Ontario has partnered with the Ontario Trillium Foundation (OTF). OTF's primary role is to provide a range of supports to organizations interested in submitting project proposals.

There are several funding streams available:

- General
- 2. Homeless Related Proposals
- 3. Indigenous-led projects

There is dedicated funding under the general stream for homeless prevention related projects.

Organizations were advised to consider <u>London's Homeless Prevention System – A Three Year Implementation Plan</u> when drafting their proposals.



Organizations that submit homelessness related projects must include a letter of support from the local service system manager (page 15 of the 2016 Call for Proposals Application Guide). The City of London, Homeless Prevention is the Service Manager.

# 8.1 City Updates/Homeless Prevention Update

Jan Richardson, Manager, Homeless Prevention provided an update.

# i) Homelessness Partnering Strategy:


On June 8, 2016 the City of London received a letter from Service Canada, Homelessness Partnering Strategy confirming that "to enhance the ongoing work to combat homelessness, an additional \$256,607 per year for 2016/17 and 2017/18 has been allocated to the Designated Communities funding stream in London through Budget 2016. This additional funding is intended to enhance the continued implementation of Housing First and complementary initiatives in your community. The supplemental funds may be used to increase funding to existing programs and services or to fund new projects in accordance with your Homelessness Partnering Strategy Community Plan priorities".

The City of London, as the Community Entity, continues to request that the Homelessness Partnering Strategy consider London as an Aboriginal Designated community.

The City of London has prepared the HPS Annual Report and has submitted it to the Steering Committee for review. Highlights will be shared with the general membership at a future meeting.

### ii) Homelessness to Housing Strategy

Jan provided a graphic illustration of the experience of homelessness noting that the longer an individual remains homeless the poorer their health outcomes, there is a higher use of emergency, health, justice and correctional services, and it will take more time, resources, and likely a longer term commitment, to achieve housing stability. This helps to explain why the current priority is chronic and persistent homelessness in the Homeless Prevention Implementation Plan. The focus of the current plan is with chronic shelter users, street involved sex workers, Urban Indigenous People, along with focussed efforts on youth to prevent youth moving into chronic homelessness.





#### **Efforts Underway**

- Voluntary reduction in emergency shelter beds from 360 to 320
- Decrease in the number of users of emergency shelters, and a decrease in long-term users
- SPDAT (Service Prioritization Decision Assistance Tool) Shelters have completed a SPDAT on chronic shelter users and are working together on collaborative case management
- London CAReS has housed over 100 individuals
- Street Level Women at Risk Program is operational
- New Housing First Youth Shelter approved for funding

# iii) Stationary Needle Bins

Seventeen stationary needle bins are currently installed at strategic locations in downtown and priority areas to assist with the collection of discarded drug using equipment. An additional four needle bins will be installed along the Thames River between Ridout and Wellington.

# iv) Missing Persons Policy

A Missing Persons policy specific to street involved sex workers has been approved by the Street Level Women at Risk Collaboration Advisory Group. The policy is being forwarded to Homes 4 Women for comment and will then be provided to the Homeless Coalition. It is expected that the Homeless Coalition policy will be generalized.

#### v)Staff Announcements

- i) Trevor Johnson, Homeless Prevention Team has been appointed to a new role in Social Services as Manager, Employment commencing June 27, 2016. Trevor will continue to champion homeless prevention and poverty reduction in London.
- ii) Dan Catunto, Ontario Works Manager, is replacing Cheryl Patience and will support the emergency shelters.
